



## Private Event Rentals

Veronét Vineyards & Winery is the perfect location for your next event. Prepare for an experience your guests will never forget overlooking acres of vines, framed by Crowders Mountain & The Pinnacle.

We have a variety of spaces to choose from, including our fully furnished indoor tasting room, front lawn that overlooks acres of vineyard, our wraparound patio with stunning views of the mountains, and our courtyard area with a dramatic staircase and plenty of picnic table seating.

**In compliance with NCDHHS COVID restrictions, maximum capacity is currently limited at 50 guests for any indoor event and 100 guests for any outdoor event.**

### GENERAL RENTAL POLICIES

The estate is available for private event rental Monday – Friday from 10:00am – 10:00pm, Saturdays from 10am to 12:00pm & after 6:30pm, and Sundays after 6:30pm. All rentals include:

- Exclusive use of the estate for two (2) hours for your event.
- 30 minutes for set-up time prior to your event.
- 30 minutes of clean-up time after your event.
- Full bar setup & attendants throughout your event.
- Use of indoor furnishings, outdoor picnic tables, outdoor Adirondack chairs, outdoor bistro tables, outdoor lawn games, two (2) chalkboard signs, two (2) 6' tables, and four (4) canopy tents.

We also have White resin folding chairs, champagne gold Chiavari chairs with white cushions & round tables available for an additional fee.

Pricing for event rentals is based on a minimum-spend model. Private events must **commit to a minimum \$600 spend for two (2) hours of estate use**. Additional time may be purchased at a minimum-spend cost of \$175 per hour. There is a separate **\$125 rental fee** in addition to your minimum spend. You must be able to meet your minimum spend in sales for your event, or pay the remaining difference in actual spend vs. minimum at the close of your event. **All event sales are subject to a 7% sales tax and 20% gratuity fee.**

There is a **non-refundable \$250 date hold fee** for all events; this fee is due at time of booking and is non-refundable should your event be cancelled. The \$250 fee is applied as a credit towards your minimum spend at your event, or can be applied towards a new date in the event of rescheduling. There is a **refundable \$250 security deposit** due two weeks before your event date. This will be refunded within 10 days of your event completion as long as facilities and furnishings are returned in their original condition.



## FREQUENTLY ASKED QUESTIONS

### WHAT IS YOUR ALCOHOL POLICY?

Veronét Vineyards & Winery wines must be purchased for your guests and no other brands of wine are allowed on site. We recommend a minimum purchase of one 12-bottle case of wine per 25 guests. Beer & liquor is also permitted with the use of an ABC Limited Special Occasion Permit that you or your caterer will be responsible for obtaining. All liquor must be served by your caterer or outside hired bartenders who meet our requirements for alcohol safety training and service. If you plan to serve liquor at your event, you will be responsible for obtaining private security to be present throughout the entirety of your event; one security officer for every 100 guests is required. ### DO YOU HAVE AN IN-HOUSE CATERER OR A LIST OF PREFERRED VENDORS?

We do not have an in-house caterer here at Veronét Vineyards & Winery. We have a list of preferred vendors who we have worked with in the past, including caterers, that we are happy to share with you. Caterers must be licensed, insured, and provide references for final approval by Veronét Vineyards & Winery before booking. Any vendor who has not previously worked at our property will be required to complete a 15-minute virtual planning session with our events team.

### ARE THERE ANY SERVICE FEES OR ADDITIONAL COSTS?

We require a non-refundable \$250 date hold fee at the time of booking, a \$125 rental fee that is added at the close of your event, and a refundable \$250 security deposit which is due two weeks before your event. All private event sales are charged a 20% gratuity fee. You are responsible for removing any equipment brought on-site for your event within 1 hour of event completion. Any equipment left on the premises by 10am on the day following your event will incur an additional charge of \$150 that will be deducted from your Security Deposit.

### ARE THERE ANY DECORATION RESTRICTIONS?

No decor that involves nails, tacks, staples, pins or tape may be used on our indoor or outdoor furnishings, and no confetti, glitter, rice grains, or similar substances may be used in any area of the estate. Open flames of any kind are prohibited. Weighted balloons, tablecloths, streamers, drapery, flameless candles, and flowers are all acceptable forms of decoration. Guests are not allowed to release balloons or pop confetti/glitter filled balloons on property.
